GRANT GUIDELINES

2023-24 Capital Support Grant Guidelines

The Trustees of The Presser Foundation created the Capital Support Committee to consider requests for grants typically between \$10,000 and \$100,000 annually to support capital projects of music organizations working in a broad range of traditions, genres, and styles. The Presser Foundation does not support theater, commercial music theater, dance, or other non-music focused venues.

Capital projects include the construction of new facilities and renovation, repair, or expansion of existing facilities. The Committee will also consider proposals for capital needs including (but are not limited to) hardware, software, and equipment. It does not include grants to cover general operating expenses, musical instruments, or supplies.

Examples of projects that have received funding:

- Construction of a new music building
- Renovation of a room to be used to house music scores
- Upgrades to audio, video, and lighting equipment
- Purchase of an outdoor screen
- Purchase of a bus for transportation of students to afterschool program
- Purchase of the software GarageBand for afterschool students
- Purchase of recording studio equipment

Applications are due by February 1.

2023-24 Special Projects

The Presser Foundation is pleased to announce that it will award \$71,500 in Special Projects single year and multi-year grants to 12 organizations.

This year, music organizations applied for grants within three of the following categories:

1) pilot projects/programs, 2) first-time, ongoing programmatic collaborations, and 3) operating support for newer organizations.

Funded projects include the creation of a new chamber ensemble for high-level performing youth, the production and sharing unique videos online to expand access of Latin chamber and popular music to schoolchildren, and a new collaboration between a well-respected music presenter and music education organization focused on Hispanic/Latinx youth.

The Foundation will also honor more than \$61,000 in previous commitments.

Philadelphia Chamber Music Society: Singing Freedom (first-time collaboration)

In a collaborative program, the <u>Philadelphia Chamber Music Society</u> (PCMS) partnered with Philadelphia's historic African Episcopal Church of St. Thomas (AECST) and Berks County's Pine Forge Academy (PFA), the historic Black boarding high school, to design and present a series of events around the themes of enslavement and liberation in the US.

As part of the collaboration, PCMS commissioned vocal works from young Black composers Mason Bynes and Shawn Okpebholo, with texts inspired by the Freedom on the Move collection of thousands of documents 'advertising' for the return of enslaved people who had self-liberated. Housed at Cornell University, this database has become a valuable historical resource, especially for Black families researching enslaved ancestors, and may be the only documentation of their relatives' lives available.

The Singing Freedom series of events, which took place over MLK weekend in January 2023, included student workshops at PFA led by visiting composer Mason Bynes (pictured in photo) to study her new piece that the PFA Honors Choir would perform on the PCMS series; a panel discussion at AECST that featured the composers, vocal soloists, and the co-founder of the Freedom on the Move database; and two public performances including the premieres of the new works in the Perelman Theater. PCMS published personal essays written by renowned Black writers, scholars and influencers in the accompanying program book, which also featured a directory of regional historical sites related to the project's theme for further exploration.

This collaboration among PCMS, AECST and PFA attracted multiple cultural partnerships that helped raise awareness of the impact of enslavement from diverse perspectives. The partnership successfully premiered works by young composers, highlighted the cultural and historical relevance of the Delaware Valley region, brought art and history to life for a new generation of students, and provided meaningful work for multiple artists.

2023-24 Undergraduate Scholar Award and Graduate Music Award

In 2023-24, The Presser Foundation will support over 250 undergraduate schools and programs of music through the Undergraduate Scholar Award program. Each higher education institution will receive \$3,000 to give to a selected outstanding music major. Read these blog posts to learn more about the **substantial changes** to the program.

In addition, 15 graduate schools of music are chosen by the Scholar Award Committee to participate in the Graduate Music Award program. Each institution selects a graduate student and their proposal for funding at \$10,000.
