## 2024-25 Special Projects

The Foundation is pleased to announce that it will award \$332,750 in Special Projects single year and multi-year grants to 22 organizations. This year, music organizations applied for grants within three of the following categories: 1) pilot projects/programs, 2) first-time, ongoing programmatic collaborations, and 3) operating support for newer organizations. Funded projects and organizations include the launch the "Philadelphia Synth Library," a pilot program that aims to create a space dedicated to analog synthesizers and related technologies; the creation of a resident community artist model by an opera company; and the support of an organization that offers workshops, curriculum, and connection on non-Western music for children, families and music educators. The Foundation will also honor more than \$43,000 in previous commitments. To learn more about the Special Projects

# 2024-25 Undergraduate Scholar Award & Graduate Music Award

In 2024-25, The Presser Foundation will support many undergraduate schools and programs of music through the Undergraduate Scholar Award program. In addition, 16 graduate schools of music have been chosen by the Scholar Award Committee to participate in the Graduate Music Award program. Each institution selects a graduate student and their proposal for funding at \$10,000. # 100th Anniversary of Theodore Presser's Passing

The Presser Foundation's founder Theodore Presser, music educator and publisher, passed away in October 1925. He filled much of his life with philanthropy, including building and supporting the Presser Home for Retired Music Teachers. After he passed away, his philanthropic legacy lived on through the establishment of The Presser Foundation.

To celebrate this milestone and 100 years of music philanthropy, the Foundation will partner with Temple University's Charles Library and its Special Collections Research Center to host an exhibit opening in Fall 2025 about The Presser Foundation. Grantees will be invited to join the Board and staff at a reception at the Charles Library that fall to commemorate the momentous occasion.

### PARTNER SPOTLIGHT



### Dolce Suono Ensemble - Music Video Modules

Seeking to more deeply engage students, **Dolce Suono Ensemble** (DSE) received a multiyear grant to produce Music Video Modules covering a variety of musical topics, with an emphasis on Latin chamber and popular music in connection with DSE's **Música en tus Manos** (Music in Your Hands) initiative. These videos, accessible online for use in class or asynchronously by anyone with an internet connection, could be used to supplement music curriculum or establish music education where there are no resources for it.

To develop the videos, DSE has collaborated with partner music teachers and groups of students to design and format the videos. Thus far, they have produced videos for students from pre-school through high school, including students who have no previous music

education to dedicated instrumental students and band members, and everyone in between. DSE artists Mimi Stillman (flute), Gabriel Globus-Hoenich (percussion), Charles Abramovic (piano), Celina Velez (violin/voice), Ahmed Alom (piano), Subin Lee (harp), and Gideon Whitehead (guitar) have produced videos thus far.

# FamFrequency Productions - General Operating Support

<u>FamFrequency Productions</u> is a music and entrepreneurship fellowship that empowers under-resourced high-school artists to build streams of income through music production and audio engineering. The organization is committed to developing entrepreneurs who will have the tools to thrive in the creative economy, as they teach topics such as marketing, business, and financial literacy, in addition to the technical music production and mixing skills they need to make commercially competitive music.

The program also connects students with industry professionals, such as music producers, sync license managers, artist managers, and marketing experts. These relationships provide insight into the various pathways to success in music and creative entrepreneurship. The exposure to such a range of expertise inspired students to take their craft seriously and to view music as a viable career path, with tangible outcomes such as client work and live performance opportunities.

This past year, 100% of FamFrequency's graduating artists were able to monetize their music in some form, whether through live performances, producing beats for artists, or securing other types of clients. Each of the 19 students completed essential industry-ready materials, including a personal brand kit and an electronic press kit (EPK), and submitted beats to local artists for collaboration.
